

CLAIM FORM

Only one claim may be submitted per Settlement Class Member and per Household, regardless of the number of Settlement Class Members residing at a particular address. In order to receive a cash or product distribution, the Claims Administrator must receive a valid Claim Form, including any proof of purchase of Lenny & Larry's The Complete Cookie or other Lenny & Larry's baked goods products and an affidavit, within 60 days (or the next business day thereafter) of the Notice Date, as specified in the Settlement Class Notice.

For Settlement Class Members who submit a valid Claim Form supported by proof of purchase of Lenny & Larry's The Complete Cookie or other Lenny & Larry's baked goods products, that Settlement Class Member may elect to receive a cash distribution not exceeding the greater of (i) the amount reflected by the proof of purchase up to \$50.00 or (ii) \$20.00. All proofs of purchase submitted to establish a \$20.00 cash distribution must be dated prior to the Notice Date. Alternatively, the respective Settlement Class Member, with proof of purchase, may elect to receive free Complete Cookies with a retail value of up to \$30.00.

[Note: Multiple proofs of purchase may be used to establish one claim. Further, because Lenny & Larry's has a record of online purchases made through its website, Settlement Class Members who purchased Lenny & Larry's The Complete Cookie or other Lenny & Larry's baked goods products online through its website do not need to submit a proof of purchase with their Claim Form to recover the amounts identified above.]

If you do not have valid proof of purchase of a Lenny & Larry's The Complete Cookie or other Lenny & Larry's baked goods products and did not purchase the product from the Lenny & Larry's website, you may elect to submit this Claim Form and affidavit to receive a single amount of \$10.00 in cash or Complete Cookies with a retail value of up to \$15.00.
